**ON STREET PARKING ORDER 2017 (VARIOUS ROADS) (PARISH OF KINGSWOOD)**  
**(STROUD DISTRICT) (VARIATION) ORDER 2024**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in The Schedule below on various roads in the parish of Kingswood, Gloucestershire.

| Charfield Road (B4062)        | Along a section on both sides of its carriageway north-west of its junction with Wooton Road (B4060)          |
| Abbey Street (41520)          | Along a section on the northern side of its carriageway east of its junction with Wooton Road (B4060)         |

***No Waiting Mon-Fri 8am-4pm (Single Yellow Line)***

| Wooton Road (B4060)           | Along a section on the eastern side of its carriageway north of its junction with Charfield Road (B4062) |
