## **EHCP Annual Review Project Update**

Gloucestershire County Council is working with stakeholders to improve the Annual Review process for children with Education, Health, and Care Plans (EHCPs). Following engagement with the education sector, we will focus on the following areas:

- Improve the Annual Review paperwork and accompanying guidance documents
- Review and improve templates for capturing CYP voice and professional advice about the child or young person.

Timeline:

- New toolkit and paperwork to be available to all settings from January 2025.
- All settings to fully adopt the new paperwork from September 2025.

We are particularly keen to hear from practitioners within the Early Years Sector to be involved in this exciting project, especially those who will contribute to the coproduction of the templates mentioned above.

The plan draws its priorities from an analysis of the data and on what children, young people, their families and partners told us about their experience and priorities. The Plan will be overseen by the Children and Young People's Wellbeing Coalition, under the One Gloucestershire Health and Wellbeing Board and Partnership.


