October is Black History Month

Whilst celebrating diversity and inclusion is part of our everyday practice, why not use this month to reflect and make meaningful changes.

When thinking about diversity and inclusion we often talk about providing children with 'Windows and Mirrors'. Think about the 'Mirror' being what the child sees in your provision that represents who they are, their family, their culture, and where they live etc. The 'Window' should provide opportunities to see the past, the people and places beyond the child immediate experiences.

How you provide 'Windows and Mirrors' for children needs to be carefully considered. This is where relationships with parents and your community are so valuable.

Top Tip – Have you thought about having a pen pal with another setting/childminder in Gloucestershire? Our inner city and town providers are rich in diversity whereas our providers in the countryside offer lots of opportunities to see animals, nature and farming. Sharing experiences and photos of your local community will naturally provide children with the 'Windows'.

Voluntary Charges

In April this year the DfE introduced new requirements relating to voluntary charges and invoicing. These changes must be fully implemented by January 2026 and includes providing invoicing information on your website or glosfamilies directory.

For providers including childminders with less than 10 children you do not need to publish this information.

The webpage information and invoicing should clearly show the following:

- the free entitlement hours
- additional private paid hours
- food charges
- non-food consumables charges
- activities charges

A FAQ and supportive guidance will also be published in the next business team's bulletin.

The DfE requested that Local Authorities must work with all providers to ensure requirements are in place by the deadline of January 2026. Because of this the business support team will be contacting all Early Years Providers in Gloucestershire to ensure their invoicing and charging requirements are compliant and offer support where needed.



Total Communication Training in the Early Years - This training is provided in house at your setting.

You can now book Total Communication in the Early Years through GCC+. To do this you will need to log into your setting's GCC+ account. Go to the **search bar** on the **home page**, and type in Total Communications and **press the search key**.

You will then see the link for the Total Communications for you to book.

(Please note – if you search in the ‘training section’ or the ‘services’ section, you won’t find it. It must be searched for in the home page search and the search key pressed). NB - If you just press enter, it

won't find it.

Once you have booked and checked out your training, you will be contacted by an EY Inclusion Advisor to arrange the date and time for the delivery of your course. If you have not heard from us within 2 weeks, please contact the EY Admin Team: eyservice@goucestershire.gov.uk.
