

**GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017
(VARIOUS ROADS IN THE PERRYBROOK DEVELOPMENT) (PARISH OF
BROCKWORTH) (TEWKESBURY BOROUGH) (VARIATION)
ORDER 2026**

Gloucestershire County Council in exercise of its powers under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 (“the 2017 Order”) shall be amended by the insertion of the new sealed plan(s) specified in the First Schedule to this Order.
2. The effect of this Order is to introduce the restrictions set out in the Second Schedule to this Order.
3. The remainder of the 2017 Order shall remain in full force and effect.
4. This Order shall come into effect on the day of 2026 and may be cited as the “GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (VARIOUS ROADS IN THE PERRYBROOK DEVELOPMENT) (PARISH OF BROCKWORTH) (TEWKESBURY BOROUGH) (VARIATION) ORDER 2026”

Birdwood Crescent (82341)	Along sections on both sides of its carriageway between its junctions with Stilchester Road (82340) and Somerdale Avenue (82342)
Farmhouse Road (82343)	Along a section on both sides of its carriageway at its junction with Somerdale Avenue (82342) Along sections on the north-eastern side of its carriageway at its junction with Appleby Close (82344) Along sections on the south-western side of its carriageway at its junction with Huntsman Drive (82345)
Appleby Close (82344)	Along a section on both sides of its carriageway at its junction with Farmhouse Road (82343)
Huntsman Drive (82345)	Along a section on both sides of its carriageway at its junction with Somerdale Avenue (82342) Along a section on both sides of its carriageway at its junction with Farmhouse Road (82343)
Strickland Close (82346)	Along a section on both sides of its carriageway at its junction with Somerdale Avenue (82342)
Finching Close (82347)	Along a section on both sides of its carriageway at its junction with Somerdale Avenue (82342)
Annatto Close (82348)	Along a section on both sides of its carriageway at its junction with Stilchester Road (82340)
