## **Wraparound**

### **What is wraparound childcare?**

- Wraparound childcare is before and after school childcare, such as breakfast clubs and after school provision for primary school aged children in England.
- The provision typically runs from 8am until 6pm, during term time, either on a school site or another local setting such as a community centre, a nursery, or a childminder.

- This is different from out-of-school activities, or school clubs, which are less frequent and can be a one-off activity.

## What is wraparound funding?

The government funding is to help schools and providers create new or expand existing wraparound childcare in ways that make sure that is affordable for working parents. The aim is that by September 2026 the new and expanded childcare will be self-sustaining and meeting the needs of the local community and families.

## Guidance for Childminders

### Operating from non-domestic premises (the 50% rule)

- You can apply to spend up to 50% of your time running childcare from non-domestic premises. Non-domestic premises include places like nurseries, church halls, parts of a school or classrooms. You need to follow the same requirements as your original registration.

### Upcoming changes

- The Department for Education has brought in changes on 1 November 2024 to give the early years sector (in particular childminders) more flexibility. These changes will see a new type of childminder introduced and give existing childminders and childcare on domestic premises providers more scope in terms of where they spend their time and base their childcare.
- The main changes have:
- created a new category of childminder called 'childminders without domestic premises'. This is for childminders who will work solely from somewhere other than a home, such as a community or village hall
- increased the total number of people (including childminders and assistants) who can work together under a childminder's registration from 3 to 4
- gives you more flexibility to operate outside of your home (or someone else's) for more of your time. This will remove the requirement that at least 50% of the childcare must be provided in a home
- mean that any childminders who want to work with 4 or more other adults (5+ in total) will need to register as 'childcare on domestic premises'

### Childminder without domestic premises

- This new category of childminder can only work from non-domestic premises. They will not be able to work from any home at any time, even during pick-up and drop-off time. A domestic premises is any home or place where someone lives.

- You can confirm whether your premises is domestic by looking at what local authority council tax rates are paid. An indication that it is non-domestic is if [business rates](#) are paid.
- If you want to choose this model, you must register as a childminder without domestic premises, unless you have an [exemption from compulsory registration](#).

### **Should I apply for NWCP funding?**

- Show that wraparound care is available from 8am to 6pm, Monday to Friday
- Offering additional places or expanding hours/ days to Mon-Fri 8-6
- Link to School
- Provide care for school age children from Reception to Year 6
- Show that you are registered correctly with Ofsted (EYR/CR)
- Confirm that you are registered with HMRC so parents can use tax free childcare vouchers/Universal Credit to pay for care
- Clearly explain how you will support individual children's needs including those with SEND
