

GLOUCESTERSHIRE COUNTY COUNCIL (LITTLEDEAN)  
(VARIOUS ROADS) (PROHIBITION OF DRIVING) ORDER, 1978

The Gloucestershire County Council (hereinafter referred to as "the Council") in exercise of their powers under Section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act, 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967 hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order.
2. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to proceed in the said lengths of road specified in the Schedule hereto for the purposes of:-
  - (i) obtaining access to premises adjacent to the said lengths of road
  - (ii) the maintenance improvement cleaning and reconstruction of the said lengths of road
  - (iii) the laying erection alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main pipe or apparatus for the supply of gas water or electricity or of any telegraphic line as defined in the Telegraph Act, 1878.
  - (iv) A Local Authority or a Water Authority in pursuance of their statutory powers or duties
  - (v) Fire Brigade Ambulance or Police purposes
  - (vi) the delivery or collection of postal packets as defined in Section 87 of the Post Office Act, 1953

3. The Interpretation Act, 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

4. This Order shall come into operation on the Nineteenth day of September 1978 and may be cited as "the Gloucestershire County Council (Littledean) (Various Roads) (Prohibition of Driving) Order, 1978".

1. The Ruffitt Lane  
(unclassified road number 40118/9) From its junction with the road known as Littledean Hill Road (unclassified road number 40117) to its junction with the road known as High Street (unclassified road number 40118)
2. High Street  
(unclassified road number 40118) From its junction with The Ruffitt Lane to its junction with the road leading from Cinderford to Elton (classified road number A.4151).

3. Reddings Lane  
(unclassified road number 40118)

From its junction with  
Littledean Hill Road to its  
junction with The Ruffitt Lane.
