Paediatric First Aid Training (Reimbursements)

As we come to the end of the financial year, the Paediatric First Aid training budget is now oversubscribed. Early Years providers asking the Council to consider a contribution to First Aid training will need to apply from the 2024-2025 budget which will open from 1 April 2024. Inspection themes - February 2024

Each week we analyse recently published inspection reports where providers have been judged as 'less than good'. Nationally we are seeing some common themes around:

- Hygiene Practices, for example - hand washing, food preparation and practices around nappy changing.

- Supporting children's behaviour – consistency regarding managing behaviours that challenge, ensuring staff have the knowledge and skills to understand children's behaviour
- Staff supervision – ensuring there is effective staff coaching, guidance and training to help staff improve gaps in their knowledge and practice
