NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed waiting restrictions detailed in the Schedule below:

Restrictions to be introduced

No Waiting at Any Time (Double Yellow Lines)

Road Name & Number	Extent
Podsmead Place (481551,481556)	Along sections on both sides of its carriageway between its junctions with Podsmead Road (481549) and Poplar Close (481553)
Chaucer Close (481552)	Along a section on both sides of its carriageway at its junction with Podsmead Place (481551)
Poplar Close (481553)	Along a section on both sides of its carriageway at its junction with Podsmead Place (481556) & Laburnum Road (481556)
Laburnum Road (481556)	Along sections on both sides of its carriageway for its entire length including the turning head at the end of the carriageway
Sycamore Close (481554)	Along a section on both sides of its carriageway at its junction with Laburnum Road (481556)
Redwood Close (481555)	Along a section on both sides of its carriageway at its junction with Laburnum Road (481556)

The lengths of roads fall within the City of Gloucester in the County of Gloucestershire.
