Check an Early Years Qualification Service

Early years managers can now use the new Check an Early Years Qualification digital service to quickly verify whether staff qualifications meet the requirements for staff:child ratios in England.

This tool allows managers to check a qualification's approval status by entering key details such as:

- course start date
- level
- awarding organisation

All other user groups (for example practitioners) should continue to use

the Early Years Qualifications List (EYQL) to check qualifications, and contact our supplier, Ecctis if they are unable to find the qualification on the EYQL.

Immunisations and Exclusion Policy:

The UK Health Security Agency has had several notifications that some early years providers have policies excluding children post vaccination. Dr Mary Ramsey, Director of public health programmes at the UK HSA says

‘While some children may experience mild side effects after vaccination, there is absolutely no medical reason to exclude a vaccinated child from a setting if they are feeling well. This practice could potentially discourage parents from getting their children vaccinated and therefore increase the risk of having outbreaks in nurseries and schools’

Please do take some time to review your current policy if it does have an exclusion period post vaccination.

Practice Spotlight

Each week we will share an area of practice that has been highlighted as a theme from inspection reports published in England during the previous term. This weeks practice spotlight is:

Effective Adult Interactions

We must never underestimate the importance of ensuring children receive high quality adult interactions. Having skilled and sensitive adults, who are responsive and knowledgeable is key to supporting children’s learning and development. However, in order to ensure our interactions with children are effective we need to ensure:

- We know the child, what they can do, what their interests are
- Our knowledge of child development is sound
- Our wellbeing is good
- We have a clear understanding of our roles and responsibilities
- We prioritise the children and their needs:

- Group times are not interrupted
- The routine is purposeful, and transitions are not too long
- Tasks such as cleaning, admin are not prioritised over children

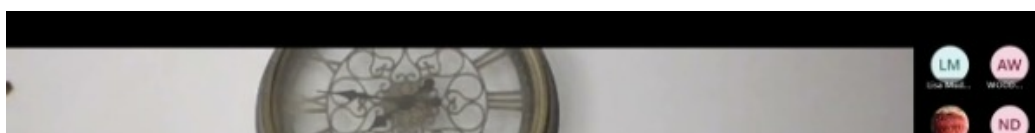
