

Gloucestershire Suicide Prevention Partnership (GSPP) Forum

Terms of Reference

1. Aim

The Gloucestershire Suicide Prevention Partnership Forum (the Forum) aims:

- to reduce the rate of suicide and self-harm within Gloucestershire
- to provide a facility for successful multi-agency partnership working at an operational level.

2. Objectives

The Gloucestershire Suicide Prevention Partnership Forum will collaborate across organisations and individuals to ensure effective joint working to reduce suicide rates in Gloucestershire.

3. Responsibilities

- To champion and promote the work of the Gloucestershire Suicide Prevention Partnership
- To take part in and contribute to the delivery of the Gloucestershire Suicide Prevention Action Plan, including through engagement in Task (& Finish)/Sub Groups
- To share good practice and learning that can contribute to the outcomes of the Gloucestershire Suicide Prevention Partnership
- To identify and share gaps or areas for improvement and opportunities and ideas for joint working projects
- To keep up to date with national and local developments in the field of suicide prevention.

Meetings will take a range of forms, including presentations, workshops and seminars. Members are encouraged to contribute at these meetings to talk about their work, which has an impact on the aims and objectives of the Partnership.

9. Newsletters

After each Forum meeting, a newsletter will be produced to provide further information and updates on members work in suicide prevention.

10. Task & Finish/Sub Groups

Members are invited to participate in the various Task & Finish/Sub Groups in operation.
