

PUBLIC NOTICE

GLOUCESTERSHIRE COUNTY COUNCIL BUS LANE ORDER 2017 (CLARENCE STREET, CHELTENHAM TRANSPORT PLAN PHASE 4) (EXPERIMENTAL VARIATION) (AMENDMENT NO. 1) ORDER 2019

NOTICE is hereby given that Gloucestershire County Council has made an Experimental Variation Amendment No. 1 Order (the Experimental Variation Amendment No. 1 Order) under the Road Traffic Regulation Act 1984, the effect of which will be to experimentally vary the Gloucestershire County Council Bus Lane Order 2017 (the Bus Lane Order) by experimentally introducing the Bus Gate described in the Schedule below along Clarence Street within the Borough of Cheltenham, Gloucestershire.

THE SCHEDULE Bus Gate to be introduced at all times

Road Name / Number	Extent
Clarence Street A46	From the east side of its junction with Post Office Lane to the west side of its junction with Imperial Circus (a distance of approximately 12 metres)

The remainder of the Bus Lane Order will remain in full force and effect.

A copy of the Experimental Variation Amendment No. 1 Order which comes into effect on 3rd June 2019, the Bus Lane Order, the sealed plan to be revoked and the sealed plan to be inserted into the Schedule of Bus Lane Order Plans together with a copy of the Statement of Reasons and other documents, may be inspected during normal opening hours at Gloucestershire County Council, Shire Hall, Westgate Street, Gloucester, GL1 2TG, Cheltenham Borough Council, Municipal Offices, Promenade, Cheltenham, GL50 9SA and Cheltenham Library, Clarence Street, Cheltenham, GL50 3JT or can be viewed at www.goucestershire.gov.uk/ctp (Please quote reference HBL/64805).

The Experimental Variation Amendment No. 1 Order is Experimental and may continue in force for a period of up to 18 months from the date of the original experimental order expiring on 28th December 2019. In due course the Council will consider whether or not the provisions of the Experimental Variation Amendment No. 1 Order should continue in force indefinitely.

Within 6 months of coming into force of the Experimental Variation Amendment No. 1 Order any person may object to its indefinite continuation. Any such representation should be sent in writing to the Head of Legal Services, Shire Hall, Westgate Street, Gloucester, GL1 2TG or via the Portal found at www.goucestershire.gov.uk/ctp-phase4 not later than 3rd December 2019 stating the grounds on which it is made (please quote reference HBL/64805).
