## EYA Central - Early Years Leaders Network



### When to contact EY S&L Support:

- ✓ EY Provider has evidenced need (eg using ECAT/progress review/RFL etc) and the child has not yet been referred to Speech and Language Therapy Service
- ✓ EY provider has implemented interventions/ resources but child is not making progress
- ✓ EY provider is unsure what interventions/resources to use
- ✓ EY provider is unsure whether to make a referral to Speech and Language Therapy Service
- ✓ EY provider wishes to discuss a cohort of children presenting with speech, language and communication delay
- ✓ EY provider would like support to develop a "communication friendly" environment
- ✓ A referral to S&L has been submitted, but the setting would like some advice/support whilst the child is waiting to be allocated a named therapist
