## **Further update about voluntary charges compliance checks**

#### **Safeguarding updates from Ofsted**

Changes to the EYFS and Keeping Children Safe in Education KCSiE come into effect this term. Please make sure you have read and understand these.

We have been working with GSCP and have made sure that all our providers, including those new to wraparound have got access to the safeguarding audit.
