Highways Licence On-Line Application Guidance

Introduction

This guidance has been provided for the new on-line licence application forms.

All licences, including renewals, are now available on the one application form. The questions you are asked will change depending on the licence type selected.

There are six sections to be completed

The first screen relates to our Privacy Notice and how we use your data. You will be unable to continue with the application until you have accepted the statement.

Once accepted, then select the “next” button to navigate to the next page.

The question “What type of licence do you require?” can be answered by selecting from the drop down menu, one of the following;

Crane Licence, or Scaffolding & Hoarding Licence, or Highways Occupation, or Highways Projection Licence or Skip Permit. The type of licence you choose here will determine what equipment you can use in the operation details section.

You will need to complete the dates that the licence is required for. Please take care when entering the dates as this forms the basis of the calculation of the fee for the licence.

Select next to move through to the next screen or previous to move back a screen. You can also use the tabs at the top of the page to navigate the application form.
