

**GLOUCESTERSHIRE COUNTY COUNCIL
(50 MPH SPEED LIMIT)
(A4136) (PARISHES OF LONGHOPE & MITCHELDEAN)
(FOREST OF DEAN DISTRICT)
ORDER 2026**

The Gloucestershire County Council ("the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 25th day of September 2026 and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL (50MPH SPEED LIMIT) (A4136) (PARISHES OF LONGHOPE & MITCHELDEAN) (FOREST OF DEAN DISTRICT) ORDER 2026".

(ii) This Order affects roads within the Parishes of Longhope and Mitcheldean within the Forest of Dean District within the County of Gloucestershire.

2. In this Order –

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.

3. No person shall cause or permit any Motor Vehicle to proceed along that length of road described in The Schedule to this Order at a speed exceeding 50 MPH.

6. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.

7. In accordance with Part IV of Schedule 9 of the Act, the following parts of Orders are to be revoked as specified in the sub-Articles that follow:

- (i) GLOUCESTERSHIRE COUNTY COUNCIL (A4136, B4228 AND B4028) (VARIOUS SPEED LIMITS IN THE FOREST OF DEAN) ORDER 2017
