

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(40 AND 50 MPH SPEED LIMIT) SPINE ROAD AND STATION ROAD SOUTH**  
**CERNEY COTSWOLD DISTRICT ORDER 2018**

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4 and 84 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 5<sup>th</sup> September 2018 and may be cited as the "Gloucestershire County Council (40 and 50 mph Speed Limit) Spine Road and Station Road South Cerney Cotswold District Order 2018"  
  
(ii) This Order affects roads in the Parish of South Cerney in the Cotswold District in the County of Gloucestershire.
2. In this Order –  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.
3. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule 1 to this Order at a speed exceeding 40 mph and along the length of road described in Schedule 2 to this Order at a speed exceeding 50 mph.
4. The Order described in Schedule 3 to this Order is hereby revoked

**SCHEDULE 1**  
**40 mph Speed Limit**

<b>Road Name &amp; Number</b>	<b>Extent</b>
Spine Road 204696	From a point approximately 150 metres south of its junction with Station Road, for a distance of approximately 1080 metres in a Northeast direction.
Station Road 300179	From its junction with Spine Road for a distance of approximately 930 metres in a Northwest direction.

**SCHEDULE 2**  
**50 mph Speed Limit**

<b>Road Name &amp; Number</b>	<b>Extent</b>
Spine Road 204696	From a point approximately 150 metres Southwest of its junction with Station Road to a point approximately 450 metres Southwest of its junction with Broadway Lane.
