'What would you do?'

The theme for this year's 16 Days of Action in Gloucestershire will be around **engaging with employers** and the **wider public** (colleagues, family, friends etc.) on **raising awareness of domestic abuse, sexual violence and wider violence against women and girls' themes**.



The campaign will focus efforts on major employers in the county and will join in the Public Health England South West campaign promoting their new domestic abuse toolkit for employers and supporting us all in **how to identify domestic abuse, how to intervene safely or advise those who disclose where to seek support**.



A full programme of activities is being planned across the county for the 16 Days of Action.

Linked to the 'What would You do?' theme for Gloucestershire's **16 Days of Action** is the **Bystander Intervention Initiative**.

The Bystander Initiative is a free resource with an educational toolkit to be used by universities and colleges for the prevention of sexual coercion and domestic abuse in university settings. It was created at UWE (University of the West of England) Bristol and funded by Public Health England.

New DASH/ MARAC Referral Form

The DASH form/ MARAC referral has been slightly amended to reflect the changes to information sharing under the Data Protection Act (DPA) 2018 (GDPR).

The form now includes tick boxes for agencies to confirm which legislation they are using to refer high risk domestic abuse cases without consent into the MARAC.

GSAB roadshows: The Safeguarding Adults Board has decided that their roadshows this year will focus on domestic abuse, raising awareness of domestic abuse in general, but highlighting domestic abuse amongst older people and those people with care and support needs. Positive Relationships Gloucestershire (PRG) is the new name for the countywide service delivering a range of interventions to address the behaviour of perpetrators of domestic abuse and to promote healthy adult relationships. The new branding reflects a broader specification for the new service, commissioned under the Gloucestershire Framework for Domestic Abuse which is being delivered by Splitz Support Service. "Are they shouting because of me?" – [click here](#) to read this new report from the **Children's Commissioner** of the voices of children living in households with domestic abuse, parental substance misuse and mental health issues. The report provides quantitative analysis on the numbers of children in England living in households where the 'toxic trio' of factors affecting adults may be present.

The **Turning the Spotlight** programme was a county-wide project carried out in Cumbria by the Brathay Trust which provided a range of interventions with children, young people and families to reduce incidents of hate crime and domestic abuse.
