The Gloucestershire Safeguarding Children Partnership

The Gloucestershire NHS Integrated Care Board, Constabulary, and Local Authority share an equal duty under the Working Together to Safeguard Children 2023 Statutory Guidance (WT2023). They must ensure that their organisations, along with any agency related to children's services, referred to as Relevant Agencies, collaborate effectively to keep children safe.

The Partnership will publish its local arrangements, outlining how it will meet its WT2023 obligations. Its Yearly Report will detail how these arrangements have been met each year.

Local Child Safeguarding Practice Reviews Including Rapid Reviews



Under the legislation Working Together to Safeguard Children Statutory Guidance the local Safeguarding Partners must have a process in place to identify, review and respond to serious safeguarding incidents that are referred to the Partners for consideration of a Local Child Safeguarding Practice Review (LCSMR).

This section will provide you with an update on serious safeguarding reviews that have taken place in Gloucestershire highlighting the learning and recommendations.

Rapid Reviews

The Partnership undertook a Rapid Review in Q4 2024/2025. One of the key findings related to an absence of any information relating to the father of the child in question.

The GSCP would like to remind colleagues of the National Child Safeguarding Practice Review's report on "The Myth of Invisible Men". The evidence gathered during this review underscores an urgent need to

improve how the system identifies, responds to, and intervenes with men who may pose a risk to the babies they care for. The role these men play in a child's life, their parenting history, and their own childhood experiences, and how these affect them as adults, are often overlooked by services responsible for safeguarding children and supporting parents.

Rapid Review Key Recommendations

1. **Professional Curiosity:** Importance of asking detailed questions and not taking information at face value.
2. **Holistic Assessment:** Need for comprehensive assessments that consider the entire family's history and current situation.
3. **Multi-Agency Collaboration:** Ensuring all relevant information is shared among agencies to better understand and support families.
4. **Support for Young Parents:** Providing targeted support for young parents with adverse childhood experiences (ACEs) to improve their parenting skills and family outcomes

The Bridge Sexual Assault Referral Centre (SARC) works to support recovery and health of children affected by sexual assault and sexual abuse.

Based in Bristol and serving the children and young people of Gloucestershire (and the wider region) regardless of when the abuse happened, we offer both acute (≤ 7 days) and historic (ARC) services.

We are available for advice and strategy invitations 24/7/365 and see CYP daily including evenings for young people when appropriate. CYP can visit us for advice, examination, forensic evidence collection, related healthcare (including STI screening) and for onward referrals. We consider non-police referrals for YP ≥ 13 years old with information sharing with children's social care in all cases. **Anyone**, including CYP, can phone us for advice.
